Executive Summary

This document deals with the research data produced, collected and preserved during the project, as well as with the way that those data will be handled after the end of the project.

The FLOBOT project abides to the European Commission's vision that information already paid for through EC funding should not be paid for again each time it is accessed or used by the research community and that it should benefit European companies and citizens to the full. This means making publicly-funded scientific information available online, at no extra cost, to European researchers, innovative industries and citizens, while ensuring long-term preservation. This will have to be done, without, of course, compromising any Intellectual Property Rights (IPR) and commercial plans of the participants.

This document describes the research data that will be produced by each of the software-related tasks of the project and the way that those will be made available. It has to be clarified that this Data Management Plan (DMP) is not a fixed document, but evolves during the lifespan of the project. Information regarding data sharing, archiving and preservation is also included.
